Check Status of Application Online

Important Note

1. You may check the status of your application on the next day after it has been submitted successfully.
2. Successful registration is only valid till 31 December of that year. Unless you apply on or after 1 October of the year, your registration will be valid till 31 December of the next year. If you are interested to be registered for as a Relief teacher for **following year**, you are required to renew it by the end of the current year (ie from 1 Dec to 31 Dec). The renewal function is available via the web address at <http://rsms.moe.gov.sg>

For foreigners without FIN number, please login using the ID generated when you first saved or submitted your application.

Step 1: To key in the Login ID

- If you are a Singaporean/SPR, the login ID is your NRIC number
- If you are a foreigner, the login ID is the Applicant Number generated when you first saved or submitted your application.

Step 2: To key in the Password

- The password is your date of birth in the format DDMMYYYY.
