OVERVIEW

The Education Endowment Scheme, commonly known as the Edusave Scheme, was established in January 1993. Its objective is to maximise and equalise educational opportunities for all Singaporeans. It aims to enhance the quality of education in Singapore and to motivate pupils to excel academically.

The Edusave Scheme is governed by the Education Endowment Scheme Act (CAP 87A). The Edusave Endowment Fund and Edusave Pupils Fund were established under the Act.

The Edusave Advisory Council was also set up under the Act for the purpose of advising the Minister for Education on the application of the income from the Edusave Endowment Fund. The first Edusave Advisory Council completed its two-year term on 31 December 1994. The second Edusave Advisory Council, consisting of five members from the business and education sectors, was appointed on 1 January 1995 for a two-year period.

The Edusave Endowment Fund received a Government contribution of \$1.0 billion from the Consolidated Revenue Account during the financial year (FY 94). The Fund is invested by the Government and is deemed to earn a fixed income pegged to the CPF interest rate. The balance in the Capital Account of the Endowment Fund as at 31 March 1995 was \$3.5 billion. The Government's target is to build up the Capital sum to \$5 billion. The rate of future contributions to the Fund will depend on Singapore's economic growth and the Government's budgetary surpluses.

During the financial year, the Edusave Endowment Fund generated an interest income of \$80.43m. With the balance brought forward of \$37.55m, the total income available in the Income Account for FY 94 amounted to \$117.98m.

Of this amount, \$73.75m was disbursed during the period in the form of contributions to pupils' Edusave accounts, grants to Government and Government-aided secondary schools, Edusave scholarships and development and operating expenditures.

The Edusave Pupils Fund comprises funds which are credited to the Edusave accounts of eligible pupils in primary and secondary schools and trainees in the Institute of Technical Education. The contribution rate is \$110 in 1995. The total contribution for the financial year amounted to \$41.19m. During the financial year, a total of \$3.69m was withdrawn for payment of second-tier miscellaneous fees, school-based enrichment programmes and payment of tuition

fees at the polytechnics. At the primary and secondary levels, 94,400 pupils made withdrawals from their Edusave accounts, representing 25.3% of the total 372,600 accounts.

In addition to the Edusave funds in the pupils' accounts, an Edusave grant of \$90 per pupil (averaging \$100,000 per school) was allocated to all Government and Government-aided secondary schools during the year to enable them to procure services and resources and introduce programmes that enhance the quality of teaching and learning. Of the allocation of \$14.67m for the financial year, \$11.14m was spent, representing a utilisation rate of 75.9%. A total of \$25.16m was disbursed to schools to cater for the reimbursement of grant imprests from April to December 1994, the half-yearly release of grants for 1995 and the release of unspent balances brought forward from 1993 and 1994.

The total value of Edusave scholarships awarded to pupils in independent schools and Government and Government-aided secondary schools during the financial year was \$6.56m.

Under the Edusave Scholarships for Independent Schools (ESIS) Scheme, scholarships are awarded to the top 25% of pupils enrolled in independent schools based on PSLE results. The scholarship is tenable for four years of education in the independent school. Its value is equivalent to the school fee of each independent school less the school and standard miscellaneous fee in the Government and Government-aided secondary schools. In January 1995, 820 scholarships were awarded to secondary one pupils. Of these, 675 were funded from Edusave funds and the remaining 145 from Voted Funds under the special programmes, ie Gifted Education Programme, Music Elective Programme and Art Elective Programme. In addition, 45 secondary one and 62 secondary two pupils were also awarded the Edusave (Independent Schools) Yearly Award in December 1994. This is given to the top 5% of pupils in each independent school based on the school examination results, and who are not ESIS holders. The total value of scholarships paid to independent school pupils from Edusave funds was \$3.19m.

For pupils in the Government and Government-aided secondary schools, 8,454 scholarships were awarded to secondary one and two pupils in December 1994 under the Edusave Scholarships for Secondary Schools (ESSS) Scheme. Under the Scheme, the top 5% of pupils at each level based on the school examination results received \$500 each while the next 5% received \$300 each. These scholarships amounted to \$3.37m.

The system development and operating cost of the Edusave Endowment Fund and Edusave Pupils Fund amounted to \$0.84m during the financial year.

As at 31 March 1995, the balance in the Edusave Endowment Fund was \$3.54 billion, including a balance of \$44.23m in the Income Account. Of this amount, \$41.87m was committed for FY 95, leaving an uncommitted balance of \$2.36m.

EDUSAVE ENDOWMENT FUND

TRANSFERS FROM CONSOLIDATED REVENUE ACCOUNT

The Edusave Endowment Fund was created on 1 Jan 93 by the transfer of fund from the Consolidated Revenue Account. The Government contributed an additional \$1.0 billion in FY 94 through a sum of \$0.5 billion each in April 94 and March 95. These contributions constitute the capital of the Fund from which income is generated for application under the Edusave Scheme. The capital sum in the Fund as at 31 March 1995 was \$3.5 billion.

INCOME FROM THE EDUSAVE ENDOWMENT FUND

The Edusave Endowment Fund is invested by the Government together with other Government funds. The Fund receives a fixed interest income based on the CPF rate of interest. The interest earned each year is used to finance the outlay under the Edusave Scheme. The interest rate was 2.50% pa from April to December 1994 and 3.10% pa from January to March 1995.

During the period under review, the Edusave Endowment Fund generated an interest income of \$80.43m. With the balance brought forward of \$37.55m, the total income available in the Income Account for the period amounted to \$117.98m.

ALLOCATION OF INCOME


Of the total income of \$117.98m, \$73.75m was disbursed during the financial year. The bulk of the disbursement, amounting to \$41.19m (55.9%), was paid into the Edusave accounts of eligible pupils. Another \$25.16m (34.1%) was disbursed as Edusave grants to Government and Government-aided secondary schools. A sum of \$3.19m (4.3%) was given as scholarships to top pupils in independent schools under the Edusave Scholarships for Independent Schools and Edusave (Independent Schools) Yearly Awards Schemes, and \$3.37m (4.6%) worth of scholarships was given out under the Edusave Scholarships for Secondary Schools Scheme. Systems development and operating expenses of the Edusave Endowment Fund and Edusave Pupils Fund accounted for \$0.84m (1.1%). The balance of the income as at 31 March 95 was \$44.23m. Of this, \$41.87m was committed for FY 95, leaving an uncommitted balance of \$2.36m.

The chart below shows the allocation of Edusave income during the financial year.

ACCUMULATED BALANCE

As at 31 March 1995, the balance in the Edusave Endowment Fund was \$3.54 billion, comprising \$3.5 billion in the Capital Account and \$44.23m in the Income Account.

EDUSAVE PUPILS FUND

CONTRIBUTIONS IN 1995

The Edusave Pupils Fund comprises Edusave funds which are paid into the Edusave accounts of eligible pupils. In 1995, the contribution rate is \$110. During the financial year, \$40.99m was paid into the accounts of 372,600 pupils in the primary and secondary schools, and \$0.20m was paid into the accounts of 2,000 pupils in the Institute of Technical Education. The total contributions amounted to \$41.19m in FY 94.

APPROVED USES

A pupil can use the money in his Edusave account to pay for enrichment programmes organised by his school such as extra-curricular activities, music and dance, educational tours, sports and games lessons etc. He can also use the money to pay his second-tier miscellaneous fees if he is in a Government or Government-aided school. In the case of independent schools, it can be used to pay for the portion of school fees (ranging from \$100 to \$200 per month) in excess of the dollar value of the school and standard miscellaneous fees of the Government and Government-aided secondary schools (\$12 per month). For autonomous schools, the fund can also be used to pay the autonomous school additional miscellaneous fees.

Some polytechnic students used their Edusave funds to pay for their tuition fees in FY 94. Eventually, university students who have accumulated Edusave funds will also be able to use these funds to pay their university tuition fees.

ANALYSIS OF WITHDRAWALS

A total of \$3.69m was withdrawn from 95,000 Edusave accounts in FY 94. The bulk of the withdrawals amounting to \$3.66m were by some 94,400 pupils in the primary and secondary schools, representing a pupil participation rate of 25.3% and a fund utilisation rate of 8.9%. The withdrawals have increased compared to the previous financial period which had a pupil participation rate and fund utilisation rate of 17.5% and 2.6% respectively. Trainees in the Institute of Technical Education (ITE) withdraw a small sum of \$4,360 during the period. Withdrawals for polytechnic tuition fees amounted to \$25,000.

Of the \$3.66m withdrawn by school pupils, \$0.77m (21.1%) was for payment of second-tier miscellaneous fees, and the remaining \$2.89m (78.9%) was for enrichment programmes. Please see Table 1.

Of the \$2.89m withdrawn for enrichment programmes, \$0.83m (28.8%) was spent on personal development programmes, \$0.54m (18.5%) on educational tours and camps, \$1.08m (37.5%) on academic enrichment programmes, \$0.14m (4.7%) on sports and games and the remaining \$0.30m (10.5%) on aesthetic activities. Details are in Table 2.

ADMINISTRATION OF EDUSAVE PUPILS FUND

The Central Provident Fund Board (CPFB) is responsible for maintaining the accounts of the Edusave Pupils Fund. Based on information furnished by the Ministry, the Board opens an Edusave account for every eligible pupil. It credits Edusave contributions to the accounts, process withdrawals and remit funds withdrawn to the schools. Interest is credited to the accounts yearly based on CPF interest rate. The CPFB sends half-yearly statements of account in February to all Edusave account holders showing the contributions, interest credited, withdrawals during the preceding 6 months and the balance in the accounts. In August, statements of account are sent only to those with transactions in the preceding 6 months.

EDUSAVE SCHOLARSHIPS FOR INDEPENDENT SCHOOLS

VALUE AND TENURE OF AWARD

Under the Edusave Scholarship for Independent Schools (ESIS) Scheme, scholarships are awarded to pupils in the top 25% of secondary one (S1) Singaporean pupils enrolled in the independent schools based on their PSLE results. The annual quantum of the scholarship is the school fees charged by the independent school (ranging from \$1,200 to a maximum of \$2,400 per year) less the amount of school and standard miscellaneous fees that pupils in Government and Government-aided secondary schools have to pay (\$144 per year). The payment of each ESIS award therefore ranges from \$1,056 to \$2,256 per annum, depending on the school fees charged by each independent school. The scholarship is tenable for the full 4 years of the pupil's secondary education in the independent school.

ESIS FOR PUPILS IN SPECIAL PROGRAMMES

Under the Edusave Endowment Scheme (Edusave Scholarships) Regulations the scholarship award of pupils in the special programmes, ie the Gifted Education Programme, Music Elective Programme and Art Elective Programme, would be funded from Voted Fund and not from the Edusave Endowment Fund. As pupils in these special programmes in independent schools are subsidised in their school fees, the changes will enable more pupils who are not in these special programmes to qualify for ESIS from Edusave Funds.

1995 ESIS AWARDS

In 1995, 820 scholarships were awarded to secondary one pupils, an increase of 14 scholarships (2%) over the 806 scholarships awarded in 1994. Of these, 675 scholarships, amounting to \$1.02m were funded from Edusave funds while the remaining 145 were funded from Voted Fund. Another \$2.05m was also disbursed to the 648 scholars in secondary two and 642 scholars in secondary three during the financial year.

EDUSAVE (INDEPENDENT SCHOOLS) YEARLY AWARDS

In addition to the ESIS, pupils in independent schools may also be awarded the Edusave (Independent Schools) Yearly Award. This award is given at the end of each academic year to the top 5% pupils in each independent school who are not already ESIS holders. The Yearly Awards reward pupils who were not selected for the 4-year ESIS award for excellent academic performance achieved in the year.

Selection for the Yearly Awards is based on the pupils' school examination results for that year. The value of the Yearly Award is equivalent to the annual value of the ESIS.

1994 YEARLY AWARDS

In Dec 1994, 45 secondary one pupils and 62 secondary two pupils in the independent schools were given the Yearly Awards, amounting to \$120,270.

EDUSAVE SCHOLARSHIPS FOR GOVERNMENT AND GOVERNMENT-AIDED SECONDARY SCHOOLS

Pupils in Government and Government-aided secondary schools are eligible for Edusave scholarships under the Edusave Scholarships for Secondary Schools (ESSS) Scheme. Pupils in the top 5% of each level will receive annual scholarships of \$500 each while those in the next 5% will receive \$300 each. Selection is based on the academic performance in each year.

1994 ESSS AWARDS

The scholarships were awarded and paid out to secondary one and two pupils in December 1994. The awardees were selected from the different academic courses (Normal/Express/Special) by their Principals.

A total of 8,454 secondary one and two pupils were awarded the scholarships. Among these, 5,100 awards went to secondary one pupils and 3,354 to secondary two pupils. Of the 3,354 secondary two pupils, 1,875 had received the award when they were in secondary one. Out of the total number of awardees, 4,153 pupils received the \$500 award and 4,301 pupils, the \$300 award. The total amount paid out was \$3.37m. Details can be found in Table 4.

The breakdown of the awards by course shows that 3,334 (40%) awardees were from the Normal Course, 4,734 (56%) from the Express Course and 386 (4%) from the Special Course. Details are shown in Table 5.

On the whole, the distribution of the awards among the three courses was fairly even. The awards were given to 9% of the Normal Course pupils, 11% of the Express Course pupils and 11% of the Special Course pupils. Principals have rewarded not only the bright pupils in the Special and Express Courses, but also those in the Normal Course to motivate all pupils to put in their best effort in their studies. Details are shown in Table 6.

EDUSAVE GRANTS FOR SECONDARY SCHOOLS

AMOUNT DISBURSED

Edusave grants are given to all Government and Government-aided secondary schools to enable them to procure services and resources and introduce programmes that enhance the quality of teaching and learning. The grant is pegged at \$90 per student, which works out to an average annual grant of about \$100,000 per school.

A total of 143 Government and Government-aided secondary schools were allocated Edusave grants in FY 94. The amount allocated for the financial year ending 31 March 1995 was \$14.67m.

The Edusave grants were operated under the imprest system till December 1994. The amount reimbursed to the schools' imprests was \$11.52m. From 1995 onwards, the schools' allocation for the year would be disbursed to them in two instalments in January and July each year. The first half-yearly release for 1995 was \$7.56m. In addition, the balance of unspent grants brought forward from 1993 and 1994, amounting to \$6.08m, was also released to schools in March 1995. In total, the amount of Edusave grants disbursed to schools during the financial year was \$25.16m.

UTILISATION OF GRANTS

Of the allocation of \$14.67m for FY 94, \$11.14m was spent by the schools, representing 75.9% of the grant allocation. This was an increase compared to 62.1% in the previous financial period. Of the total amount spent, \$3.23m (29.0%) was for the purchase of resources and equipment and \$6.62m (59.4%) on enrichment programmes. About \$0.64m (5.8%) was used for administrative support services while the remaining \$0.65m (5.8%) was spent on miscellaneous items. On the whole, schools have used their Edusave grants well. Table 7 shows a breakdown of the major categories of expenditure.

To assist schools in sourcing for enrichment programmes, the Ministry has worked in collaboration with the Singapore Teachers' Union (STU) to develop a good supply of enrichment programmes that are of reasonable quality and give value-for-money. With the assistance of STU, schools will have a wider choice of good enrichment programmes starting from 1995.

During the financial year, 112 (78%) out of the total of 143 secondary schools, had spent more than 50% of their grant allocation. Table 8 shows the percentage of Edusave Grant spent by schools in FY 94.

1 PRINCIPAL ACTIVITIES

The Edusave Endowment Fund was established on 1 January 1993 under the Education Endowment Scheme Act (CAP 87A). The income generated by the Fund is to be used for the following purposes:

- 1.1 the provision of contributions to the Edusave Pupils Fund;
- 1.2 the provision of scholarships to full-time pupils at prescribed schools;
- 1.3 the provision of grants to Government and Government-aided schools to be used to enhance the quality of education; and
- 1.4 such other purposes authorised under the Act, including administrative expenses.

2 BASIS OF ACCOUNTING

The accounts are prepared on a cash basis. Income is recognised when received and expenses are recognised when paid.

3 ACCOUNTING YEAR

The accounting year is based on the Government financial year from 1 April 1994 to 31 March 1995.

5 INCOME

The CPF interest rate is used to compute the interest income of the Fund. The rate was 2.50% pa from 1 April 1994 to 31 December 1994 and 3.10% pa from 1 January 1995 to 31 March 1995.

6 CONTRIBUTIONS TO EDUSAVE PUPILS FUND

The Edusave Pupils Fund consists of contributions made from the Edusave Endowment Fund to the Edusave accounts opened for eligible Singaporean pupils between the ages of six and sixteen, studying in prescribed schools. The money is to be spent on enrichment programmes organised by the schools, second-tier miscellaneous fees and other approved fees. The rate of contribution to each account was \$100 in 1994 and \$110 in 1995. The contributions for the past years were as follows:-

i) Edusave Scholarships for Independent Schools (ESIS)

The top 25% of Singaporean pupils enrolled in the independent schools based on the PSLE results are eligible to receive the ESIS. These scholarships cover their school fees less the school and standard miscellaneous fees in Government and Government-aided secondary schools throughout their four-year secondary education in the independent schools. Pupils from secondary one to three were paid the scholarship award in January/February 1995. In addition, the top 5% pupils based on the school examination results who are not in receipt of the four-year ESIS, would receive the Yearly Award at the end of each year. The Yearly Awards were paid to both secondary one and two pupils at the end of 1994.

ii) Edusave Scholarships for Secondary Schools (ESSS)

The ESSS are yearly awards given at the end of every school year to the top 10% pupils of each level in the Government and Government-aided secondary schools based on their examination results for that year. Scholarship awards for both secondary one and two pupils were paid at the end of 1994.

8 GRANTS TO GOVERNMENT AND GOVERNMENT-AIDED SECONDARY SCHOOLS

The purpose of the grant is to enable schools to procure services and resources and introduce programmes that enhance the quality of teaching and learning. The grants were operated under an imprest system up to December 1994. From 1995 onwards, grants would be released to schools in two instalments in January and July each year. The \$25,157,898 and \$10,057,419 disbursed to schools in FY 94 and FY 93 respectively comprised the following:

In compliance with Section 17 of the Education Endowment Scheme Act (CAP 87A), charges by Central Provident Fund (CPF) Board for administering the Edusave Pupils Fund were paid out of the Edusave Endowment Fund. An advance is paid to CPF Board to meet these administrative expenses. The balance of the advance brought forward from the previous financial period was \$304,965. An advance of \$434,228 was disbursed to CPF Board in FY 94. The expenses billed by CPF Board for FY 94 was \$470,934 as shown below, leaving a balance of \$268,259 in the advance account. The comparative figures for FY 93 have been re-presented to conform with the FY 94 presentation.

1 PRINCIPAL ACTIVITIES

The Edusave Pupils Fund, managed by the Central Provident Fund (CPF) Board, receives contributions from the Edusave Endowment Fund which are credited to the Edusave accounts of eligible Singaporean pupils. The money can be withdrawn and spent on enrichment programmes organised by schools, the second-tier miscellaneous fees, tertiary tuition fees and other approved fees.

2 BASIS OF ACCOUNTING

The accounts are prepared using the cash basis of accounting adopted by the Government.

3 ACCOUNTING YEAR

The accounting year is based on the Government financial year from 1 April 1994 to 31 March 1995.

4 INTEREST CREDITED TO MEMBERS' ACCOUNTS

Interest credited to members' accounts was based on the CPF interest rate of 2.50% pa from 1 April 1994 to 31 December 1994 and 3.10% pa from 1 January 1995 to 31 March 1995.
