FREQUENTLY ASKED QUESTIONS (FOR PARENTS)

ACCESS

- **Can I use my computer/laptop to access the P1 Registration Portal and submit registrations?**

Yes! The P1 Registration Portal is accessible through internet browsers on Windows PC, Mac, tablets and mobile devices. The recommended browsers are Google Chrome and Safari.

- **I do not see any details of my Singapore Citizen (SC) / Permanent Resident (PR) child, the phase(s) and/or school(s) that my child is eligible for in due for P1 registration when I log in to the P1 Registration Portal. How do I register my child?**

A child's eligibility for P1 registration is based on the information MOE has of the child and their parents. If you do not see any details of your child, their eligible phase(s) and/or school(s) due for P1 registration in the P1 Registration Portal, you may have the other parent log in and register the child. If the other parent also cannot see the information, use the online form in the P1 Registration Portal to register.

- **Are the access rights limited to one parent only?**

No, both parents can access their child(ren)'s information when they log in to the P1 Registration Portal. Parents without custody of the child(ren) will not be able to access the child(ren)'s information.

FREQUENTLY ASKED QUESTIONS (FOR PARENTS)

LOGIN/FEEDBACK

- **Why am I required to use Singpass to login?**
Singpass is the national digital identity for Singapore Citizens and Permanent Residents to access Singapore Government e-services easily and securely. The P1 Registration Portal uses Singpass for MOE to identify you and your child(ren) who are eligible for the exercise.
- **How do I apply for Singpass?**

- **I forgot my Singpass password. How do I reset it?**
If you have set up your Singpass 2FA, you can reset your Singpass password online [here](#).
- **How can I provide feedback on the P1 Registration portal?**
Feedback can be provided via the portal through [Help us improve] widget in the bottom left.

FREQUENTLY ASKED QUESTIONS (FOR PARENTS)

REGISTRATION

- **I cannot see my Caregiver address in the registration form.**
Please click [here](#) to see the conditions of using a caregiver address before submitting a registration for your child(ren) through the P1 Registration Portal.
- **Do both parents have to submit the registration for the child(ren)?**
Only a single registration for the child(ren) is required. Once a registration is submitted, both parents will be able to view the submitted registration. Should there be a change, only the parent who has submitted the registration is able to remove the registration.
- **I have more than 1 child, can I submit 1 registration for the same school for all my children?**
Yes, you can select multiple children to submit 1 registration for the same school.
- **I have more than 1 child, can I submit different registrations to different school for my children?**
Yes, you can select 1 child to submit a registration first, then submit a different registration for the 2nd child to a different school.

FREQUENTLY ASKED QUESTIONS (FOR PARENTS)

REGISTRATION

- **How do I edit a registration that has been submitted?**
If there are changes to the registration, you may remove the existing registration and submit a new one. If the registration is submitted for multiple children, removing the existing registration affects all the children in that registration. A new submission is required for all affected children.
- **I am unable to remove the registration submitted for my child(ren). Why is this so?**
Only the applicant who have submitted the registration is able to remove the registration. Please contact the applicant to proceed with removing the registration.
- **I am unable to withdraw the school admission for my child. Why is this so?**
Only the applicant who has submitted the registration is able to withdraw the child from the admitted school. Please contact the applicant to withdraw your child from the admitted school.
