**The Grant from MOE for year 2017 of amount \$1.139 million comprised:**

- 1) Actual Reimbursement from MOE in year 2017 is \$ 866,686
- 2) Balance due from MOE is \$273,000 which had not been received by school in year 2017. Although total \$1.139 million(95%) has been paid to contractor within the year, Auditors did not nett off these figures and indeed keep these amount as WIP (95%) per Audit Report. There would be an overstatement of Fund balance due to this 95% from MOE that remains in the Balance Sheet as WIP (95%) as per Audit Report 17.
