FREQUENTLY ASKED QUESTIONS (FOR PARENTS)

ACCESS

- **Can I use my computer/laptop to access the SPERS-Sec Portal?**

Yes! The SPERS-Sec Portal is accessible through internet browsers on Windows PC, Mac, tablets and mobile devices. The recommended browsers are Google Chrome and Safari.

- **After logging in, I do not see my child's details or the details are incorrect. What should I do?**

Please fill up the form which is available in the SPERS-Sec Portal after login and provide the required information. The form will be forwarded to MOE HQ for their assistance.

- **Who can access the SPERS-Sec Portal?**

Parent can access their child's information. However, parent without custody of the child(ren) will not be able to access the child(ren)'s information.

FREQUENTLY ASKED QUESTIONS (FOR PARENTS)

LOGIN/FEEDBACK

- **Why am I required to use Singpass to log in?**

Singpass is the national digital identity for Singapore citizens and residents to access Singapore Government e-services easily and securely. The SPERS-Sec Portal uses Singpass for the Ministry of Education to identify you and your children who are eligible for the exercise.

- **How do I apply for Singpass?**

- **I forgot my Singpass password. How do I reset it?**

- **How can I provide feedback on the SPERS-Sec Portal?**

FREQUENTLY ASKED QUESTIONS (FOR PARENTS)

APPLICATION

- **Do both parents have to submit the SPERS-Sec application for the child?**

Only one parent is required to submit the application for the child. The applicant has to obtain and declare consent from the other parent when submitting the application. After submission, both parents with custody of the child will be able to view the submitted application.

- **How do I edit an application that has been submitted?**

You cannot edit an application that has been submitted. If there are changes to the application, you may remove the existing application and submit a new application before the application period closes. Please refer to the Section 5: Remove Application of this guide.

- **I am unable to withdraw the application for my child. Why is this so?**

Only the applicant who submitted the application can withdraw the child from the application. Please contact the applicant to remove your child's application.
